# Alpha of Oklahoma Chapter Appeal for Dues

I am proud that I was elected to Phi Beta Kappa – like you. And like most of you, I am not a member of the OU faculty or staff. I serve for two reasons: the stimulation of meeting outstanding faculty and staff who give so many volunteer hours to our chapter, and the belief that Phi Beta Kappa carries out an important mission on our campus.

Our primary mission is the careful selection and election of members-in-course, seniors and juniors. But we have a supporting mission of maintaining the prestige and values of Phi Beta Kappa by bringing an annual Phi Beta Kappa Visiting Scholar to campus, holding an annual Founder's Day event, featuring an important speaker, providing the two top prizes for Research Awards held each spring, and selecting the annual recipients of the Savoie Lottinville, Ann Taylor Sewell, and Mary Esther Saxon yearly scholarships, and eventually the Roland Lehr scholarship.

These missions require money in addition to hundreds of volunteer hours. Our funding comes from two sources - initiation fees and your donations and dues. The initiation fee of \$75 may sound high. Consider that \$55 of that amount goes to the national chapter, and the remaining \$20 subsidizes students who cannot pay and the initiation ceremony itself. With a small annual grant from the Provost and the Dean of the College of Arts and Sciences, we barely break even.

For the remaining activities, we rely on the support of our wide membership - YOU. Perhaps we should say "annual donation" rather than "annual dues." Think of \$25 as a suggested amount. The chapter is grateful to all those who give and support the mission of Phi Beta Kappa. - Patti Gipson, Treasurer

## **Junior Scholarship Selection and 2007 Winners**

The Phi Beta Kappa junior scholarships are now open to all juniors with a 3.7 GPA or greater at OU to improve the quality of applicants, ensure the best candidate is chosen, and honor the original intent of the scholarship endowment. Early in the spring semester, an invitation to apply for the junior scholarships will be sent to all students via OU email. The PBK scholarship committee will then review all applications and select the best ones, regardless of the student's potential membership in Phi Beta Kappa.

#### 2007 Endowed Scholarship Recipients

The Mary Esther Selby Saxon Award is presented to graduating Phi Beta Kappa seniors who plan to do graduate work in any field of the humanities or the social sciences. The committee named two winners for 2007, Lindsey Flewelling (\$750) and Carilyn Giuliano (\$750). The Amy Sewell Taylor award, given to juniors who show promise of being nominated to Phi Beta Kappa, went to Kelsey Martin (\$750).

Two students received the Savoie Lottinville award, given to juniors who show promise of being nominated to Phi Beta Kappa. The committee selected Steven K. Battles (\$500) and Bethany Burklund (\$200).

In addition to the endowed scholarships, two Undergraduate Research Awards were given in the name of Roland Lehr to students judged to have presented the best papers at Undergraduate Research Day. The winners were chosen by a system of ranking by faculty members in attendance. The first Roland Lehr prize for best Undergraduate Research Day paper (\$250) went to Ms. Amanda Ward of Tulsa for her paper "Phosphorelay Signaling Protein SSK1 in Yeast Saccharomyces cerevisiae." The second prize (\$200) went to Ms. Melissa Musser of Amarillo, TX for her paper "Development of Trunk Neural Crest in the Sea Lamprey."

## **Visiting Scholar Report**

Dr. James J. Sheehan of Stanford University came to campus on September 10 and 11 as a part of the Phi Beta Kappa Visiting Scholars Program. His visit was co-sponsored by the Department of History and the School of International and Area Studies. In addition to guest lecturing in undergraduate classes, he gave a lunch seminar on September 10 titled "The Evolution of the International System in the 20<sup>th</sup> Century." The following day, he delivered a public lecture to an audience of more than 100 at the Sam Noble Museum of Natural History titled "Why the European Union Will not Become a Superpower." Dr. Sheehan began teaching modern European history at Stanford in 1979 and is now Dickason Professor in the Humanities, a senior fellow of the Institute for International Studies, and the Paul Davies Family University Fellow in Undergraduate Education. He is the recipient of four teaching awards, a Guggenheim fellowship, a Humboldt Research Prize, and an NEH fellowship. Look for his forthcoming book, The Eclipse of Violence: The Transformation of Twentieth-Century Europe.
